### **2026 REYZIN STYLISH CASH COOLED/FROZEN SHIPPED SEMEN CONTRACT**

The undersigned Mare Owner hereby agrees on this \_\_\_\_\_ day of \_\_\_\_\_, 2026, to breed the mare named below to the Stallion REYZIN STYLISH CASH, AQHA Registration number 6239215 for the 2026 season (February 2 – July 10) subject to the following conditions:

**The Stallion Service Fee is \$2,000.00, (which includes a non-refundable \$500.00 booking fee). This completed stallion service contract, and a copy of Mare's registration papers (front and back) must be received along with the breeding fee, booking fee and shipped semen fee, prior to semen being shipped. Breeding season starts February 2 and ends July 10. We collect semen from stallion Monday, Wednesday and Friday. All forms and payment need to be completed in advance of requesting semen. All other terms and expenses shall be due according to the schedule(s) listed below. Genetic Health Testing Results: GBED N/N, HYPP N/N, HERDA N/N, MH N/N, PSSM1 N/N. Stallion carries MYHM=N/MyN**

1. Mare shall be healthy and in sound breeding condition. A photocopy of both sides of the registration papers of your mare must accompany this contract.
2. This contract contains a Live Foal Guarantee for the initial contract year when the mare has been pregnancy checked and declared to be safe in foal by a veterinarian. It is agreed that a Live Foal is defined as a newborn foal that stands and nurses without assistance. If the mare miscarries, aborts, or the foal is born dead. Mare owner agrees to provide the Stallion Manager a veterinarian's statement within seven (7) days. **Return privileges are for the following year only.** If the mare owner fails to return the mare for breeding the following year, then any and all fees paid shall be forfeited, the right to re-breed is canceled and the stallion owner and manager are released from further obligation of this contract, unless otherwise agreed upon in writing and signed by all parties. The Live Foal Guarantee in this contract is non-transferable and non-assignable. Should the mare be sold or disposed of prior to the birth of the foal the Live Foal Guarantee shall be void. However, Ramona Wold may, in her discretion, (upon application and payment of a new \$500 Booking Fee), continue to honor the Live Foal Guarantee. In the event Ramona Wold agrees to the transfer or assignment of the Live Foal Guarantee under the terms of this contract, then the new owner agrees to be bound by all terms and conditions hereof as far as the same may then be applicable.
3. Stallion owner and management do not make any warranty or representation as to the quality or confirmation of the foal, merchantability or fitness for a particularly purpose, or that the foal will be free of any infirmity, conformation defect, disease or inherited trait.
4. All rebreed and donated contracts will have a \$500 non refundable booking fee due with their contract. Shipping Fees are additional.
5. If Mare dies or becomes unfit to breed, Owner may return during this season or the following season with a substitute mare approved by the stallion owner. A mare substitution fee may apply.
6. It is further understood that should the Stallion die, or become unfit for service for any reason, then this contract will become null and void and both parties are relieved of any further obligation hereunder.
7. **Cooled Semen Shipments:** Each cooled semen shipment costs \$500. The fee(s) are paid in full prior to shipment. It is imperative that the Shipping Container be returned to Ken Wold Training Stables & Stallion Services within three days from the date of semen delivery. Owner will be charged a \$50.00 per day late charge for each day after being released. The equitainer and its components must be returned complete and in good condition. If any of the components are damaged or missing, the cost of replacement will be charged to Owner's account. Should Owner fail to return the equitainer, Mare Owner agrees to pay for its value of \$500.00. Equine Express II shipping boxes value at \$50 and need to be returned within 7 days of shipment being received. All containers will be insured for \$500.00 upon shipment to veterinarian and should be shipped back to sender with the same amount of insurance. Mare owner or veterinarian may not refuse or fail to pick up EEII or Equitainer once it has been shipped. **Semen requests must be received by calling in, or texting by 5pm the day prior to shipment. NO EMAILS ACCEPTED.** All shipments are shipped FedEx Priority Overnight unless directed by Owner. Should client request or FedEx only delivers to the specific area with FIRST Overnight then Owner will be required to pay the difference. Generally the difference in fees begins at \$150 beyond the \$500 fee. It is understood that all subsequent cooled semen shipments, if necessary, must be paid in advance by Owner of mare at \$500 per shipment. A credit card must be on file for all shipments.
8. **REYZIN STYLISH CASH** will be collected Monday, Wednesday and Friday and on off days where holidays apply. There will be no exceptions. It is the responsibility of Owner and his/her veterinarian to confirm our shipping days. There is no guarantee of availability of cooled semen. It is a first order first priority system. Stallion has extensive show schedule. Frozen semen will be available will stallion is at a show. If cooled semen is required please call to confirm breeding calendar.
9. Ken Wold Training Stables, Ken &/or Ramona Wold and KM Performance Horses/Mary C Aronson, only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit. Ken Wold Training Stables does not guarantee the fertility of said stallion, but agrees to process each ejaculate to optimize 24-hour post cool motility, and subsequent fertility. Every effort should be made to inseminate Mare within 24 hours after collection from Stallion. Owner agrees to use all cooled semen provided by this agreement for the mare named in this agreement, and no other.
10. For semen picked up at the ranch or dropped off locally, a collection fee will be charged. Picked up semen fee is \$250 per dosage. Owner or courier will not be allowed to arrive for semen pick up before the pick up time given by stallion manager. All semen deliveries are at the discretion of stallion manager and not guaranteed.
11. Shipments to Canada are subject to shipping fees. i.e. Completed Health Certificate, courier, etc. as applicable.

**12. Frozen Semen Shipments:** Frozen Semen may be available. There is a transfer fee of \$250 per request. Shipping is \$500 per shipment plus the cost of FedEx shipping. Dry Shippers must be returned to Ken Wold Training Stables within 3 business days of receiving the shipment. It must be insured for \$2,000. If the Dry Shipper is not received by Ken Wold Training Stables within 3 days of receiving, a \$100 per day fee will be charged until our office receives the Dry Shipper. Frozen semen will be shipped First Overnight, a minimum of \$150 for the additional FedEx shipping fee will apply, depending on the location of shipment, fees may be higher. If you request frozen semen you are responsible for all costs in preparing the dry shipper as well as transfer fees whether or not you cancel the order.

**13. Embryo Transfer(s):** Mare owner agrees to notify stallion manager that this is an embryo transfer mare. In the event of multiple embryos from a flush/aspiration, Mare owner agrees to pay a stallion fee of \$2,000 for each additional live foal. Additional Breeder Certificates will be issued upon receipt of necessary fee(s).

**14. Vitrified/Frozen Embryos:** Mare owner agrees to notify Stallion Manager that the embryo was vitrified within 24 hours of recovery. If vitrified embryos are utilized in the off season, than the contract is considered fulfilled. Any further re-breed rights are at the discretion of the stallion owner/manager and to be agreed upon up front and in writing. All nomination fees are solely the responsibility of the mare owner.

**15.** A Breeders Certificate will be issued when stallion management has been notified that a live foal has been produced and all stallion fees and other expenses have been paid in full. Stallion is subscribed to the NRCHA Stallion Stakes. It is the responsibility of the Mare Owner to contact the NRCHA to subscribe their offspring to the NRCHA Stallion Stakes the year it is born. The nomination date is November of the foaling year.

**16.** The parties acknowledge that this agreement is made and shall be entirely performed within the State of California and shall be construed and enforced under the laws of the State of California - mutual consent of the parties hereto.

**17.** There is no guarantee of the semen delivery time or quality upon arrival. In the event of insufficient semen on a particular breeding day, we will ship on a first ordered, first serve basis. Depending on the demand, only one dose of semen should be expected. Client is responsible for the payment of semen once it has been collected, processed and packaged, regardless if it is picked up or shipped. Failure to pay will result in a breach of contract and client forfeits its privilege to reorder semen or have breeders certificate. Mare owners are responsible for the cost of returning all shipping containers (i.e. Dry Shipper, Equitainer, Equine Express II etc. )

**18.** Contracts may not be sold. Transfer or gifted contracts are upon the Stallion Owners discretion.

**All paid Fees, including but not limited to, the Breeding fee(s), will NOT be refunded for any reason.**
